Standard Operating Procedure

1. Purpose

This SOP describes the process for becoming a Military Service Buyer with CertificationPoint.org to include associated fees based on available accounted types.

2. Scope

The intended audience for this SOP are registered businesses for military and/or Individual Service Buyers.

3. Prerequisites

The prerequisites associated with becoming a vesting member consist of site registration as a Service Buyer.

4. Responsibilities

Registered businesses for military members and individual service buyers are responsible for their account management. There are two registration types for registered Service Buyers. The first is a basic account and the second is a 'GOLD' account registration. Posting jobs and projects requires available account funds. Funds can be added to an account. Funds can be added via Paypal.com our primary online payment processor. The fee for posting jobs is \$99. The fee for posting a project is \$15, with an additional \$5 fee for featured projects.


